Overall objectives:

- to increase dissemination of information among inhabitants of border regions and to stimulate the cross-border co-operation;
- to improve the living conditions of the population;
- to increase opportunities for getting jobs for citizens living in border region





Activities

- 2 partner meetings – workshops;
- Elaboration of research studies;
- Generalization of results of the research studies;
- Development of partners' homepages;
- Other dissemination activities.





Outputs (1):

- 3 reports on situation in cross-border labour market (ES, LT, CH);
- 2 research studies on situation in cross-border labour market of ES and LT border regions;
- 1 general research study on situation in labour market executed;
- 2 meetings – workshops organized;
- Developed and supplemented websites of the partners;
- Booklets published in 1.000 copies;





Outputs (2):

- Participation in the TF workshop (2007);
- Presentation of the experience in the Annual Conference of the RFO “Change on Borders” (2007);
- Organized press conference;
- Exchange of experience and best practices between the regions;
- Recommendations and specific proposals for further improving the cross-border labour market situation elaborated.





Results

- Enlargement of experience of each participant;
- Common knowledge base on partner regions;
- Increased dissemination of information on situation in cross-border labour market in partner regions;
- Partnership consolidated;
- Improved network for future co-operation and new projects.





Recommendations (1)

- Creation of proper and widely accessible regional database of demanded labour force;
- Formation of flows of labour market directed by local employment agencies;
- Establishment of a specialized employment centre/service;
- Organization of special training in accordance with the specific character of a foreign border region;





Recommendations (2)

- Regular meetings of employers of the neighbouring territories, joint seminars, trainings etc.;
- Institutions sharing in the formation of employment policy should include promotion of the movement of labour market into the national labour market policy measures and give due attention to them;
- Simplification of procedures of visa issue and employment;
- Reduction of legal restrictions for foreign employees.





Achievements

- The overall objectives of the project were achieved:
 1. *to increase the dissemination of information among inhabitants of border regions* – this objective was achieved through the research studies (which are available in the websites and offices of the partners), booklets disseminated in the cross-border regions, flyers, articles in press.
 2. Thus *opportunities for getting jobs for citizens living in border regions increased* and that would *improve the living conditions of the population*.
- The cross-border cooperation was stimulated as the co-operation network among partners themselves and other institutions of partner border regions has been developed.
